A. Vision Agreed:

 NLCC residents are well informed of State and Borough road improvement projects and traffic safety initiatives in our area and have the opportunity to provide timely and meaningful input and positive influence on project prioritization.

B. Mission Agreed:

- The NLCC Road & Traffic Safety Committee enables the NLCC Board to:
 - i. Engage in the capital improvement project process in a timely and proactive manner providing meaningful community input to the MSB and AK DOT early in the planning, prioritization, and project design phases.
 - ii. Identify gaps in road or traffic safety projects or initiatives that need to be addressed within the boundaries of the NLCC and bring these items forward in a timely manner.
 - iii. Coordinate with Mat-Su Borough and State of Alaska administration (planning departments) and legislative contacts to successfully deliver completed projects, improvements, and safety initiatives.

C. Committee Activities and Goals (initial):

- i. Review existing MSB and State DOT publications to identify existing projects or initiatives planned or underway within the NLCC area.
- ii. Gather road and traffic safety data (traffic levels, accident frequency, etc.) to help inform our processes and prioritization.
- iii. Identify and prioritize (with community input) road and traffic safety issues and concerns.
- iv. Set up an initial committee meeting with Borough and State Planning managers to begin networking, communications, and gain understanding of process(es) for engagement.
- v. Determine most leveraging way to engage or provide timely input to ongoing State level discussions about infrastructure priorities and funding within the Mat-Su, and more specifically, within the NLCC area boundaries.
- vi. Establish and document a deliberate process by which the NLCC provides input to long range community infrastructure planning processes.

- vii. Complete the agreement with the MSB to deploy Radar speed signs within the NLCC and get them deployed. Establish a process to prioritize future deployments. Coordinate with MSB and State DOT for deployment on State roads.
- viii. Work with the Communications Committee to improve the sharing of Road and Traffic safety information and to gather input from our members and area residents.

 - Initial plan is face-to-face monthly meetings.
 - Other special meetings as appropriate (ie: Meeting with Borough and State Planning Managers) Rachel is going to reach out to Kim Sollien with the Borough to get this set up.

 - Will explore potential of using NLCC googledrive for document exchanges, etc. Rod will discuss with Theron.
