## Permits for Mobile Home Parks MSB Assembly may repeal

The Borough Assembly is considering an ordinance to repeal code requirements for permitting Mobile Home Parks. This action would remove requirements for a vegetated visual buffer between mobile home parks and surrounding properties. Additionally, residents would no longer have an opportunity to voice concerns through a public hearing with the Planning Commission. The Planning Commission unanimously opposes the change, but the MSB Assembly will make the decision through their votes.

There will be a public hearing on this proposed change at the MSB Assembly Meeting on Tuesday, August 6th at 6:00 pm.
