- 1. 1/29/25 Outgoing: Sent a Mailchimp email to subscribers regarding the NLCC feedback to the Waterbody Setback Advisory Board. Also posted on several community Facebook Group pages. Included letter in meeting packet for our 1/30/25 Membership Meeting.
- 2. 1/28/25 Incoming: MSB Planning office sent an email with the agenda and meeting packet information for the February 3rd Planning Commission meeting public hearing on the Conditional Use Permit for Central Gravel Products near the intersection of Bogard and Engstrom. The NLCC is preparing for written and verbal communication at this public hearing. Several concerns raised by the NLCC and area residents have been addressed. The primary remaining concern is still the driveway access is planned to Bogard Road and no mention of the option of future driveway access to a potential new MSB connector road between Engstrom and Trunk.

It appears the community concerns regarding proposed traffic conflicts with aircraft operations have been heard and those proposed conflicts have now been removed from the CAMP recommendations.
