# NORTH LAKES COMMUNITY COUNCIL SUMMARY OF CORRESPONDENCE & ACTIVITY SINCE LAST MEETING ...

#### **December 18, 2025**

# 1. 12/18/25 Meeting: MSB Platting Board

- Public Hearing for Vanda Valley Subdivision proposed just north of Shaw Elementary School and connecting to Foxtrot, Kilo, and Wasilla Fishhook.
- NLCC submitted prior comments / concerns / recommendations (click here).
- Rod Hanson testified on behalf of the NLCC at the meeting.
- o Outcome: will be covered verbally at the 12/18 NLCC meeting.

# 2. 12/18/25 Meeting: MSB Administrative Permit for ATT Tower at 3600 E. Bogard.

- NLCC did not review and take a position. We did, however, spread word to property owners along the airstrip to the south on the north shore of Mud Lake, making sure they were aware of the upcoming public hearing if they wanted to request lighting on the top of the tower for aviation safety.
- Rod Hanson testified (as an individual) in support of a lighted tower.
- Outcome: will be covered verbally at the 12/18 NLCC meeting.

#### 3. 12/18/25 Meeting: Joint MSB Assembly / State Delegation

Unable to attend.

#### 4. 12/17/25 Meeting: NLCC Road & Traffic Safety Committee / MSB Coordination

- Members of the NLCC R&TS Committee met with MSB representatives to discuss several topics. (see attached)
- These meetings continue to be productive and will continue into 2026.

# 5. 12/17/25 Meeting: MSB Abbreviated Plat

o Did not attend. No agenda items in the NLCC area.

#### 6. 12/16/25 Meeting: Assembly - Topics of interest included:

- Wind Storm Disaster 7 day extension, another week to 12/23/25. Approved.
- Gravel Pits: Update on Borough owned land suitable for gravel pits. None within NLCC. Staff working on proposed code changes.
- Annexation of Chugiak / Eagle River Resolution: Postponed indefinitely. Allows Eagle Exit initiative to proceed without confusion.
- Gov't Peak Chalet: Borough is taking over management and approved use fees.

- Subdivision Lot Size Reduction from 40,000 minimum to 30,000 minimum.
   Postponed and referred to the Platting Board for 90 days. Comes back to Assembly in March of 2026.
- Land Use Review Ordinance: Also postponed for 90 days.
- o Pedestrian Easements / 10-ft Setbacks. Postponed until January 20th.
- Alcohol at the Big Lake Recreation Facility (now Borough owned) Previously operated by the Lions and allowed alcohol at certain events upstairs. The Assembly voted to no longer allow alcohol to be served at events (such as weddings and funerals) at this MSB facility. They will also be considering the same stance for the Government Peak facility.
- Vacancy Report several board assignments approved. Did not include the Planning Commission District 6 position. They are still accepting any applications from District 6.
- Waterbody Setbacks January 20th at 4pm Discussion by Assembly and Staff.
   Unsure if there will be public testimony. NLCC will attend.

## 7. 12/15/25 Meeting: Planning Commission

- Amendments proposed for Lake Management Plan introduced for public hearing on January 5, 2026. (<u>click here</u>).
- Public Hearing: Planning Commission Resolution supporting Adoption of the Matanuska-Susitna Borough Hazard Mitigation Plan 2026 Update. Result approved.

#### 9. 12/12/25 Meeting: NLCC Road & Traffic Safety Committee / DOT Coordination

- Members of the NLCC R&TS Committee met with DOT representatives to discuss several topics. (click here)
- These meetings continue to be productive and will continue into 2026.

#### 10. 12/10/25 Discussions: Boys & Girls Club

- Boys & Girls Club of Alaska announced they are shutting down their organization and will not be re-opening the facility on Bogard road.
- NLCC President contacted the B&GC corporate office in Anchorage to confirm.
  Then reached out to the building owner, CST Properties (Marty Kinkaid) in
  Palmer. We articulated our desire to continue a partnership with the building
  owner and/or a new tenant to allow for continued monthly NLCC meetings.
- Update: 12/18/25 NLCC President met with Marty Kincaid and a representative of the B&G Club on site to remove his TV, wall mount, and remote.
- NLCC has clearly communicated our ownership of the electronic sign and our willingness to share use of the sign with the building owner and a future tenant.

- If we are no longer welcome in the building, we may consider moving the sign to a new location. The sign cost the NLCC approximately \$35k several years ago.
- Discussions continue. We are hopeful to receive donations of tables and chairs from the Boys & Girls Club. We are also hopeful that the new building tenant will agree to an ongoing partnership allowing NLCC meetings to continue.

## 11. 12/10/25 Meeting: MSB Abbreviated Plat

Did not attend. No agenda items in the NLCC area.

## 12. 12/9/25 Meeting: Joint Assembly / School Board

 Did not attend. The agenda was a State Legislative priority and budget discussion.

## 13. 12/9/25 Meeting: MVP / MPO Technical Committee

## 14. 12/9/25 Outgoing: Comments (personal) re: ATT Tower 3600 Bogard

- Sent personal comments to Borough regarding the proposed tower. Did not send as NLCC because of timing and inability for membership discussion.
- Requested addition of a light on top of the tower to address safety concerns of pilots going in and out of the small airstrip along the North shore of Mud Lake.
- Also reached out to pilots / property owners on the strip and encouraged them to also submit comments and attend the public hearing.
- Notified membership of opportunity to comment via Facebook.

#### 15. 12/5/25 Outgoing: NLCC Email to Assembly Members

- o Invited Assembly Members to join our Mailchimp distribution list.
- o Fonov, Nowers, Sumner, and Bowles are now on our list.

## 16. 12/5/25 Outgoing: Mailchimp Distribution: Planning Commission Vacancy

 Sent an email letting people know there is a vacancy for District 6 Planning Commissioner (to be put forward by the Mayor for Assembly confirmation).
 Encouraged interested parties to apply.

#### 17. 12/4/25 Meeting: MSB Platting Board

- Did not attend. No platting actions in the NLCC area.
- A Resolution regarding reduction of minimum lot size from 40,000 SF to 30,000 SF was discussed. The Platting Board did not feel they had enough information about the proposal to make a recommendation. Scheduled for Assembly public hearing on December 16th. The Platting Board agreed on a substitute resolution asking the Assembly to postpone action until the Platting Board has had time to get more fully informed, and not before 1/1/26.
